Conditions of Permit

Violation of these permit terms, conditions, requirements, or special provisions, including producing amounts of groundwater in excess of the authorized groundwater production of this permit, is punishable by civil penalties as provided by the Rules of the District and revocation of this permit.

The subject well field of this permit shall be accessible to district representatives for the purposes of collecting groundwater samples and the authorized operator agrees to cooperate fully in any reasonable efforts to collect groundwater samples from the subject well by the district representatives.

The permitted entity shall not operate the subject well field unless groundwater production is monitored in a manner sufficient to satisfy the groundwater production reporting requirements of the Rules of the District.

Groundwater production from the wells of the subject well field shall be reported to the District in accordance with the Rules of the District.

The application pursuant to which this permit has been issued is incorporated into this permit.

This permit is granted on the basis of and is contingent upon the accuracy of the information supplied in the associated application(s).

Special permit terms and conditions that are determined to be inconsistent with the Rules of the District shall prevail.

This permit is conditioned upon the permitted entity complying with the rules of the District and regulations of the State of Texas, as amended, applicable to operating and maintaining water wells within the District. This permit confers only the right to use the permitted wells under the provisions of the rules and according to the terms of this permit. The permit term and condition may be modified or amended pursuant to the rules of the District.

The permitted entity is authorized to operate the specified wells in accordance with the following conditions and provisions:



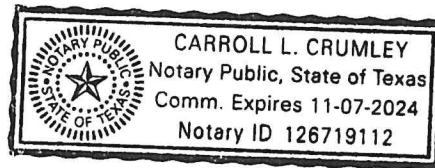
